### Categorization

Uponor is a downstream user according to article 3 no. 13 of the Reach regulation and therefore not obliged to register its products / systems. Downstream users have to guarantee within the set time limits that they are using only registered substances.

### Basis on which conformity is declared

Uponor is aware of the European Reach regulation (Regulation (EC) No 1907/2006 of the European Parliament and of the Council of December 18<sup>th</sup>, 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals) and later corrigendums to it.

According to article 31 (1) of REACH-regulation suppliers of substances, listed in the so called candidate list (substances of very high concern), are obliged to provide its consumers with a Safety Data Sheet, among other things. Furthermore article 33 of the regulation obliges the supplier of a product which includes a substance of the candidate list in a concentration > 0,1 % (w/w) to inform its consumers with at minimum the name of the substance. Therefore Uponor will control on a regular basis whether its suppliers fulfil their obligations under the REACH regulation regarding Uponor products / systems.

Uponor hereby declares based on information provided by its suppliers that its products / systems comply with the requirements of the Reach regulation. In case that the substances mentioned in the most recent list of substances of very high concern (published by the European Chemicals Agency (ECHA), Link: <http://echa.europa.eu/web/guest/candidate-list-table> ) are contained in Uponor's final products in concentrations above 0.1 % (w/w) Uponor shall disclose them in its Safety Data Sheets.
